#### NORTH WALES FIRE AND RESCUE AUTHORITY

The Local Authorities (Allowances for Members) (Wales) Regulations 2007

### **Purpose of Report**

1. To inform members of the provisions of The Local Authorities (Allowances for Members) (Wales) Regulations 2007 in relation to fire and rescue authorities and to seek approval for consequential amendments to the Authority's 'Scheme for the Payment of Members' Allowances'.

## **Background**

2. In December 2004, following the enactment of The Local Authorities (Allowances for Members of Fire Authorities) (Wales) Regulations 2004, North Wales Fire Authority established its 'Scheme for the Payment of Members' Allowances'. This Scheme came into effect retrospectively from 29<sup>th</sup> September 2004 - the date the Regulations permitted such a scheme to come into effect.



## **Background** (continued)

- **3.** A letter, dated 9<sup>th</sup> February 2005, from the then Welsh Assembly Government (WAG) Minister for Finance, Local Government and Public Services signalled the WAG's intention to review, and consolidate, the regulations governing councillors' allowances. The Minister's letter also contained a number of proposals for inclusion in the revised regulations. At its meeting on 25<sup>th</sup> April 2005 the Authority's Executive Panel considered the Minister's proposals and agreed on a detailed response which was subsequently sent to the WAG.
- **4.** Following this a further consultation was undertaken during the autumn of 2006 when the WAG published the draft Local Authorities (Allowances for Members) (Wales) Regulations 2007. These draft Regulations were considered by the Authority at its meeting on 18<sup>th</sup> December 2006 and its observations were submitted to the WAG. The report presented to the above meeting (item 13 on the business agenda) also updated members on issues which the Authority had raised in its response to the original consultation.

#### **Information**

- **5.** The new Regulations were approved by the National Assembly on 28<sup>th</sup> March 2007.
- **6.** From a fire and rescue authority perspective these Regulations amend The Local Authorities (Allowances for Member of Fire Authorities) (Wales) Regulations 2004. The amendments provide:
  - a requirement for fire authorities to set a time limit for the receipt of travel and subsistence claims (paragraph 9 of North Wales Fire Authority's Scheme for the Payment of Members' Allowances already covers this);



## **Information** (continued)

- in addition to the present requirement to publish the total amounts of basic and special responsibility allowances paid to members in each financial year, authorities will also be required to publish the total amount of care, travel and subsistence allowances paid to members during any financial year;
- for the correcting of minor drafting errors in the 2004 Regulations.
- for the introduction of the power for fire authorities to decide if they wish to pay a cooptees' allowance to nonelected members with voting rights e.g. independent members of the Standards Committee. The publication requirements will also apply to recipients of cooptees' allowances.
- 7. The 2007 Regulations come into force in two stages. The legislation on the first three points listed above came into force on 1<sup>st</sup> June 2007 with the final point coming into force during the latter part of 2008. The reason for this is that the Regulations stipulate that the maximum cooptees' allowance payable by a fire authority cannot exceed the average of the cooptees' allowance in the constituent authorities. Local authorities will not be able to determine the level of cooptees' allowances payable to non-elected voting members until the Independent Remuneration Panel publishes its initial report, which has to be published by 31<sup>st</sup> July 2008. Therefore fire authorities will be unable to calculate the maximum amount of cooptees' allowances which they can pay to non-elected members until after that date.



## **Information** (continued)

**8.** As a result of the revised Regulations some consequential amendments are required to the Authority's Scheme for the Payment of Members' Allowances. For ease of reference these amendments have been listed in the Appendix to this report.

#### 9. Recommendations

#### That:

- **9.1** members note the enactment of The Local Authorities (Allowances for Members) (Wales) Regulations 2007 and the provisions of the Regulations in relation to fire authorities;
- **9.2** in due course the Authority will give consideration to awarding a cooptees' allowance, and the level of any payments, to independent members of its Standards Committee; and
- **9.3** approves the consequential amendments to the Authority's Scheme for the Payment of Members' Allowances as detailed in the attached Appendix.
